PROGRESS OF HEALTH SUPPLEMENT BEVERAGE FACTORY

Monos Foods company has offered 122 million shares, 30 percent of its shares to public and successfully raised MNT 8.6 billion. With invested fund, company is building beverage factory which is more technologically advance as complying with international standards of GMP, ISO 9001:2015, HACCP. Currently progress of the factory interior and office interior are 85% and 95% respectively.

Completion of the plant will be in November 2019 and with the completion of the plant, the production capacity will increase by 24 times compared to today, as well as diversification of new products and expansion of the market locally and internationally.


